What's Next: Legislative Updates for Seniors

So much is happening at the legislative, state and federal levels as it pertains to the health and well-being of our seniors. At the state level, this was a challenging legislative session; however, there was some good news for programs for Florida's elders. The Legislature approved a \$4 million increase for Community Care for the Elderly and a \$3 million increase for the Alzheimer's Disease Initiative, as well as a \$352,174 increase for Aging and Disability Resource Centers. These increases are statewide.



For our seven counties in northeast Florida specifically, our request for \$400,000 in Local Service Program funds to serve older adults home-delivered meals on the waiting list was approved. We are now waiting for the Governor to sign the budget bill; and if approved the funding will go into effect July 1, 2017.

At the federal level, we narrowly escaped a government shut down as Congress finally passed the 2017 budget, which runs through September 30, 2017. Only modest increases to congregate meals (\$2 million nationwide) and home-delivered meals (\$1 million nationwide) were approved. Elder Rights and Adult Protective Services received funding increases — from \$2.5 million to \$13.87 million. Unfortunately, the Senior Community Service Employment Program (SCSEP) program incurred an 8 percent funding reduction and SHIP (State Health Insurance Assistance Program), known as SHINE in Florida, was reduced by

As Congress begins working on the 2018 budget, efforts are being made to increase overall funding for the Older Americans Act program and services, as well as to reject additional cuts to the SHIP and SCSEP programs and restore funding. Everyone's advocacy efforts, educating elected officials on the importance of these programs for older adults, helping them to live and age with independence and dignity in their homes and communities, are greatly needed. This is a great opportunity to "Age Out Loud," tying nicely into this year's Older Americans Month theme.
